Scope and Contents of the Collection

Clippings, photographs, and other materials documenting the career of Dr. John J. Lentz, Davidson County public health director for over 40 years.

Biographical/Historical Note

Dr. John J. Lentz spent over half of his medical career as Davidson County's Health Director, first appointed in 1920 and serving until his retirement in 1964. Born in Shelbyville, Tennessee, in 1885, Dr. Lentz graduated from Vanderbilt University School of Medicine in 1906. After working in Gibson and Maury counties as a general practitioner, Dr. Lentz came to Davidson County in 1913 as assistant superintendent of the Davidson County Asylum.

Public health was a priority for Dr. Lentz from childhood. A 1955 *Nashville Banner* profile of Dr. Lentz asked "Why public health?" His answer: "I lost a sister with diphtheria and a father with lockjaw."¹ Dr. Lentz spent his career campaigning for many causes, most notably polio vaccinations. After one of his sons was stricken with polio at the age of 2 and left with a slight limp, Dr. Lentz worked to vaccinate all Davidson County schoolchildren, sometimes over the violent disapproval of their parents. He also worked to eradicate infectious diseases such as diphtheria and typhoid, sometimes fought with government officials over sewers and sanitation, advocated rabies vaccinations for dogs, and lowered the rate of tuberculosis in Davidson County.

The end of his career in public health was filled with controversy. Dr. Lentz opposed consolidation in 1963, saying, "My interest is in the public health aspects of this community,....I have not advocated adoption of the 1962 Metro Charter and I am not satisfied with its provisions in regard to public health."² In the face of this opposition,

the Davidson County Board of Health re-appointed Dr. Lentz as county health director in 1962, with the knowledge that this appointment would carry over to the new government. In 1961, Dr. Lentz and the health department stopped mass polio vaccinations for schoolchildren, shifting the responsibility to parents and doctors.

Dr. Lentz retired as head of the Metropolitan Government of Nashville & Davidson County Health Department in 1964, after spending over 40 years working to improve the public health of its citizens. He died in 1970, and was buried in Woodlawn Cemetery.
